**ORDER APPROVING TRUE-UP ADJUSTMENT TARIFF**

Issue Date: December 11, 2024

Effective Date: December 25, 2024

On November 25, 2024, Evergy Missouri West, Inc. d/b/a Evergy Missouri West, submitted revised tariff sheets for the Company's first annual true-up of Securitized Utility Tariff Charge Rider (SUTC). Those tariff sheets bear a December 25, 2024, effective date.

The Commission directed its Staff (Staff) to file a recommendation about Evergy West's true-up adjustment tariff sheets and set time for other responses.

Section 393.1700.2(3)(e), RSMo. requires Evergy West to, at least annually, file a petition or letter applying a formula-based true-up mechanism adjusting the SUTC for the Commission's approval.

Staff filed a recommendation on December 5, 2024, stating that Staff had reviewed Evergy West's workpapers for mathematical or clerical errors in the calculation of the securitized utility tariff charge. Staff stated that it also reviewed the *Amended Report and Order* to ensure that Evergy West's filing followed the Commission's order. Staff

recommends that the Commission approve Evergy West's true-up adjustment tariff sheets to take effect on December 25, 2024.

The Commission reviewed the tariff sheets and Staff's recommendation and finds that the tariff sheets should be approved. The Commission will approve Evergy West's tariff sheets to become effective on December 25, 2024. Accordingly, the Commission finds it reasonable to make this order effective in less than 30 days so that the order will be effective concurrently with the tariff sheets.

1. The following tariff sheets filed by Evergy West on November 25, 2024, assigned Tracking No. JE-2025-0079, are approved to become effective on December 25, 2024:
